Rules:

- ❖ Artists must open for business on time and are not allowed to leave before the conclusion of the gala.
- ❖ The sale of non-original promotional items is prohibited.
- ❖ All work displayed must be for sale.
- ❖ The artists or his/her representative must transact all sales.
- ❖ All artists are responsible for collecting, reporting, and remitting their own sales tax.
- ❖ All artists are responsible for furnishing and setting up their own booths/tents, including tables and chairs.
- ❖ No displays, equipment, art, panels, racks, tables, chairs, etc can be set outside the front of the booth or in walkways between booths.
- ❖ Please do not block or limit visibility and/or accessibility of other booths.
- ❖ Setup can begin at 12:00 pm (noon) Friday, August 9, 2024
- ❖ All booths must be paid in full one week prior to the gala.
- ❖ For 2024, cancellations will not receive a refund.
- ❖ Artists are guaranteed a 12' x 12' outdoor space.
- ❖ Booth layout will be adjusted as needed to keep artists, patrons and staff safe.
- ❖ Authentic Arts reserves the right to refuse any booth that does not comply with standards, or to remove items that are deemed offensive.
- ❖ All artwork must be original and created and presented by the exhibitor.
- ❖ The majority of each original piece must be of handmade components.
- ❖ No ready-made, mass-produced, resale or wholesale items are allowed, including items made from kits.
- ❖ Authentic Arts assumes no liability in cases of loss or damage to artwork.
- ❖ Insurance is the responsibility of the artists.
